

Tapestry Searching as a Non-Member

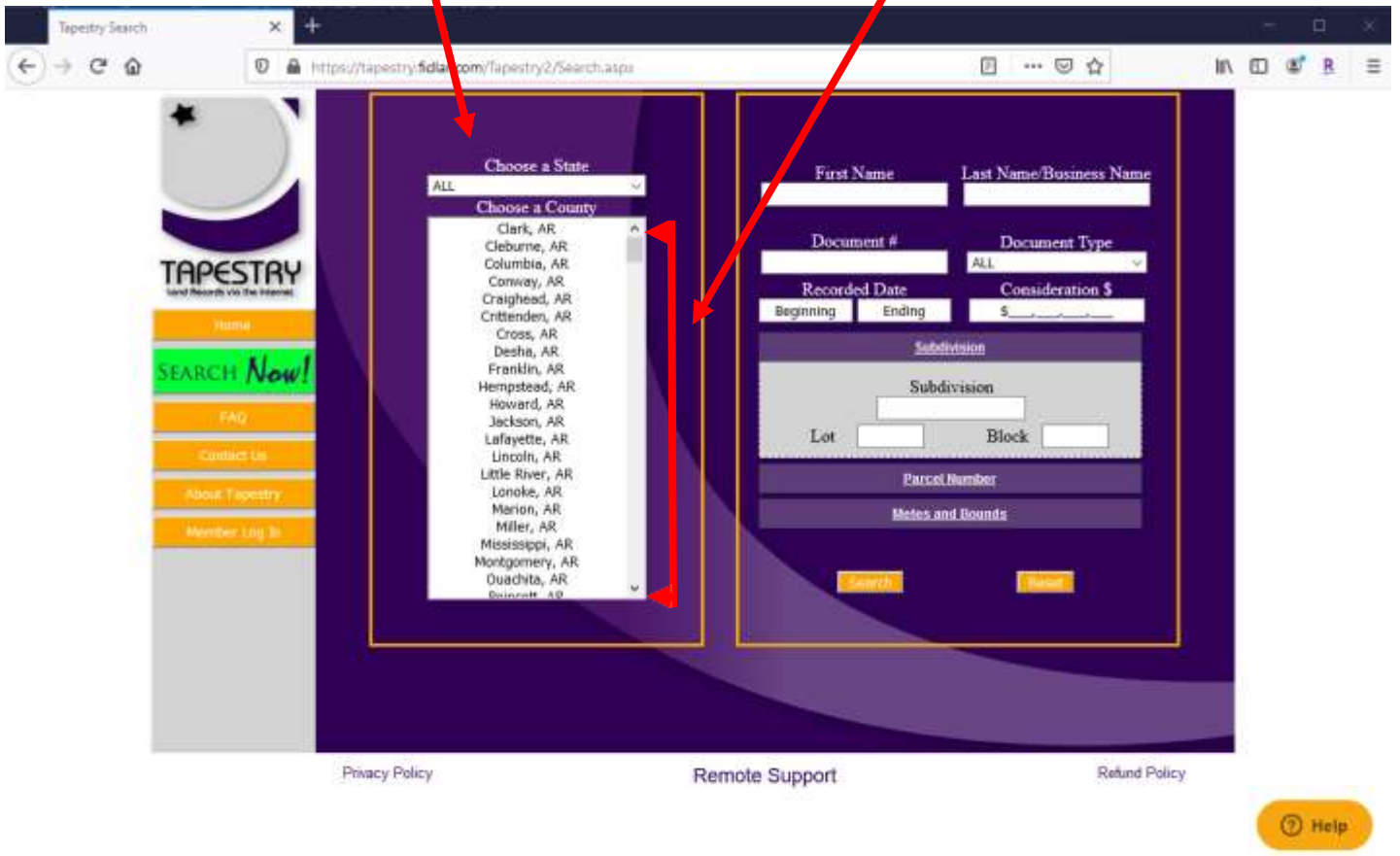
If you are not a member of Tapestry and would like to perform a “pay-per-use” search, click “Search Now!”



NOTE: While using the Tapestry site, DO NOT use your browser’s page-back and page forward-buttons. Please use only the buttons built into the Tapestry website.

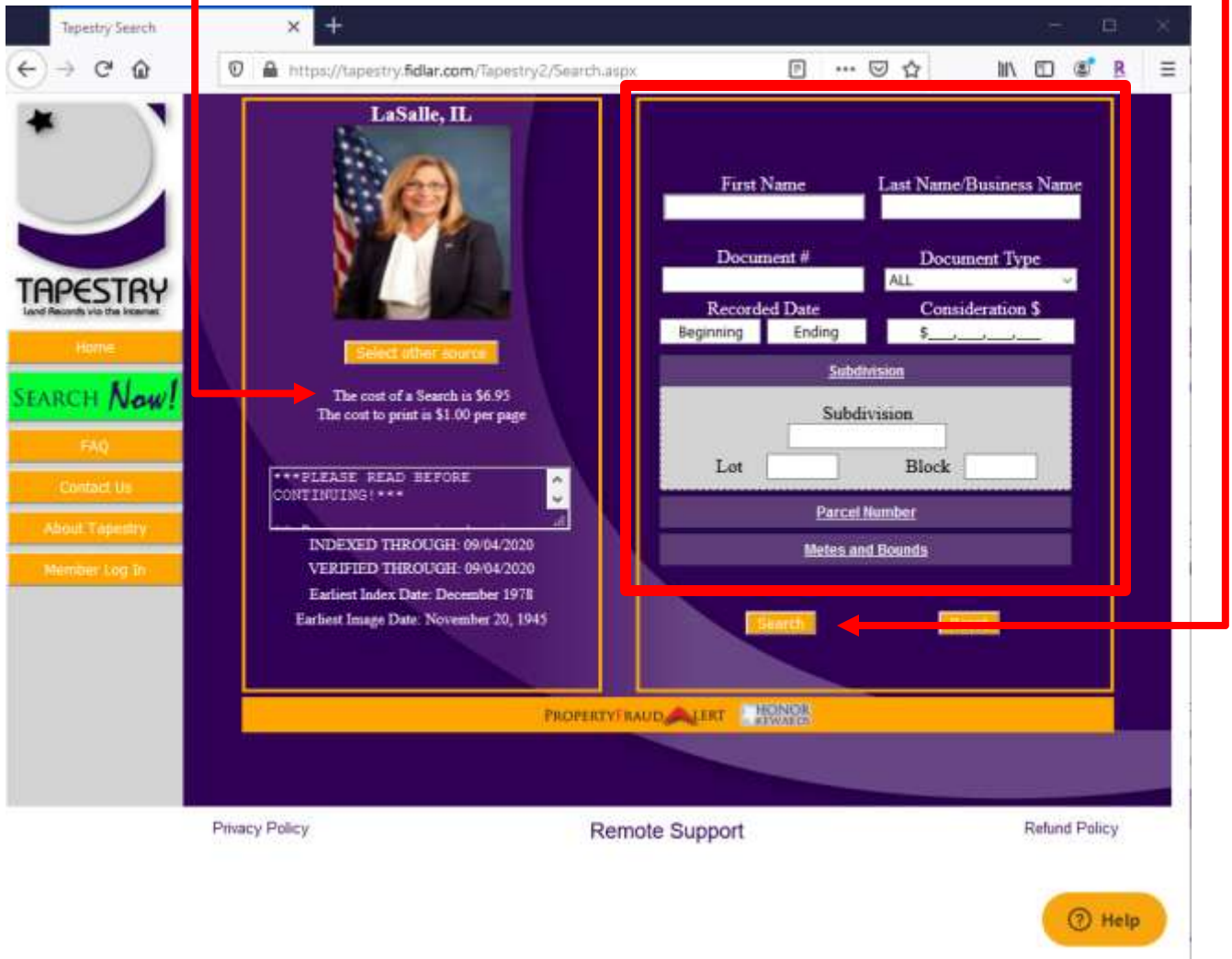
In the county list, scroll through and click on the county you would like to search.

To narrow the county list by state, select a state from the "Choose a State" drop-down menu.



Enter your search criteria in the provided fields, then click “Search.”

NOTE: Each time you click “Search”, a charge will be incurred. The current search price for this county is \$6.95.



Searching Hints:

When searching by ANY field, if unsure of the spelling, you can use a percent symbol (%) to make the search a wild card. For instance, in the “Last Name” field, if you enter “JOHN%”, this will return any matches starting with “JOHN”, an example of this would be the last name of “JOHNSON”, “JOHNS”, or “JOHNSTON”. If you do not find any search results, try broadening your search by using less fields of criteria.

First Name: Enter a party's first name.

Last Name: Enter a party's last name. If the party is a business, enter the business name in this field.

NOTE: If the party name, first name, last name, or business name contains an apostrophe, please type a percent symbol in place of the apostrophe. EXAMPLE: "Bob's General Store" should be typed in "Bob%s General Store" (excluding double quotes).

NOTE: Some counties index the first name and last name in the "Last Name" field, if so, the "First Name" field will be disabled.

Document #: Enter the document number.

Document Type: Select a doc type to narrow your search from the drop down menu. Recorded Date: Enter a recording date range for the document.

Consideration \$: Enter the consideration amount for the document.



Subdivision: Enter the subdivision name. Lot: Enter the lot number.

Block: Enter the block number.

NOTE: The subdivision name MUST be identical to how the county entered the subdivision. When searching by Lot and/or Block, you must enter a subdivision name.

Parcel Number: Enter the parcel number of the document.

NOTE: The parcel number MUST be identical to how the county entered the parcel number.

Section: Enter the section of the document. Township: Enter the township of the document. Range: Enter the range of the document.

Quarter: Enter the Quarter of the document.

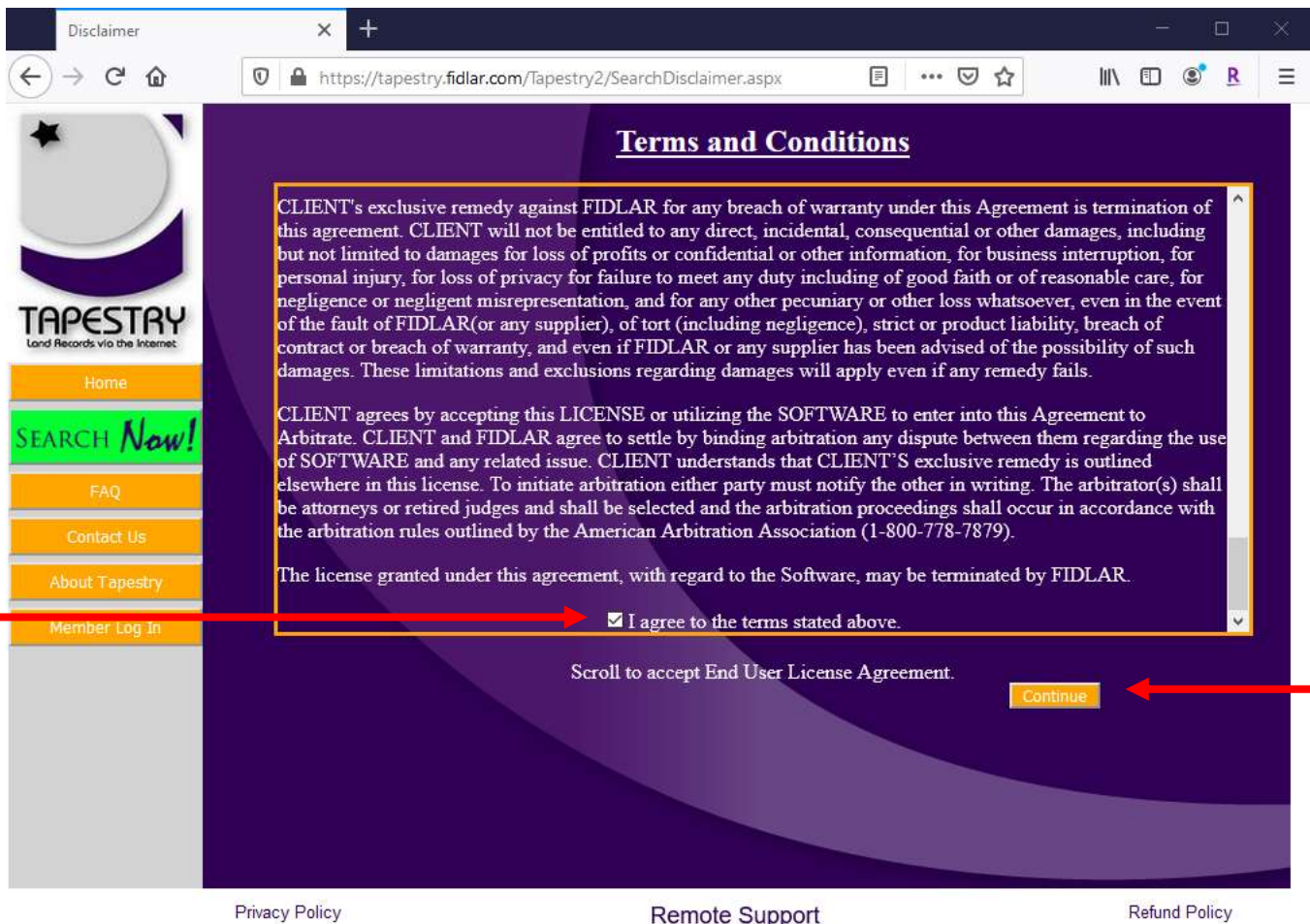
NOTE: In Tapestry, only quarters can be searched, Tapestry does not allow you to search by quarter / quarter.

NOTE: Direction can NOT be searched, only numerical values (i.e. "12" NOT "12N")

On the disclaimer page, review the term and conditions. To continue on, you will need scroll to the bottom of the information to mark the checkbox “I agree to the terms stated above”.

Now click on the “Continue” button.

NOTE: You will not be able to proceed to the next page until you have agreed to the terms and conditions.



On the credit card information page, enter your card information and then click the “Continue” button.

NOTE: Each field must be completed in order to continue.

NOTE: The search results page may display duplicate records because of multiple party names on the document (the "Last Name" field). It will not matter which record you click because the document number is the same.

NOTE: The "Print Results" button on the search results page is available if you want to print the search results records (THIS PRINT AN EXACT LIST OF THE SEARCH RESULTS DISPLAYED, NOT ANY IMAGES). If you choose to print the search results, it will prompt you as shown below. For this county the cost is currently \$9.95 for this report.

View Image: Click to preview the image(s) of the current document.

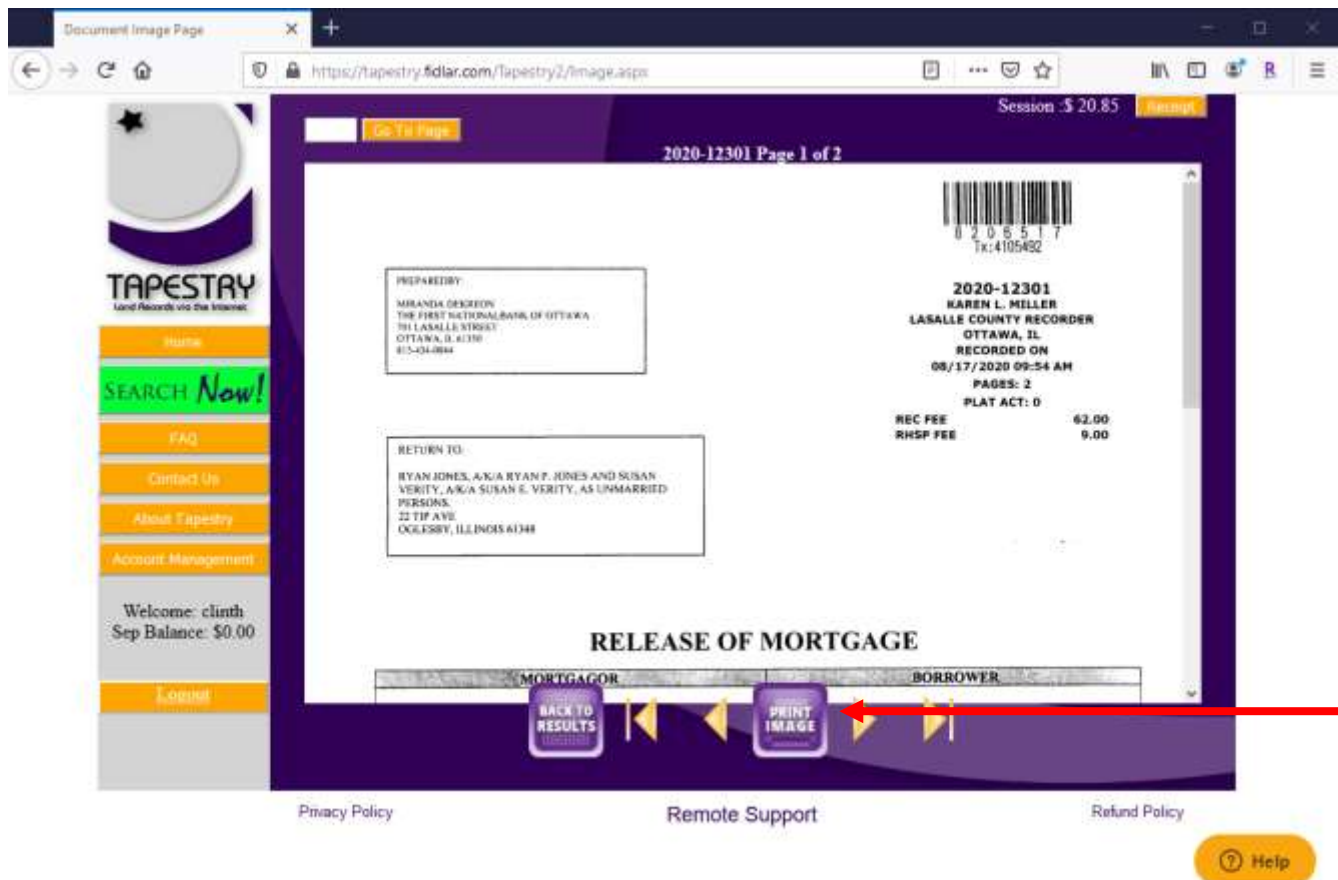
Next Document: Click to view the document details of the next document in your search results.

Last Document: Click to view the document details of the last document in your search results.

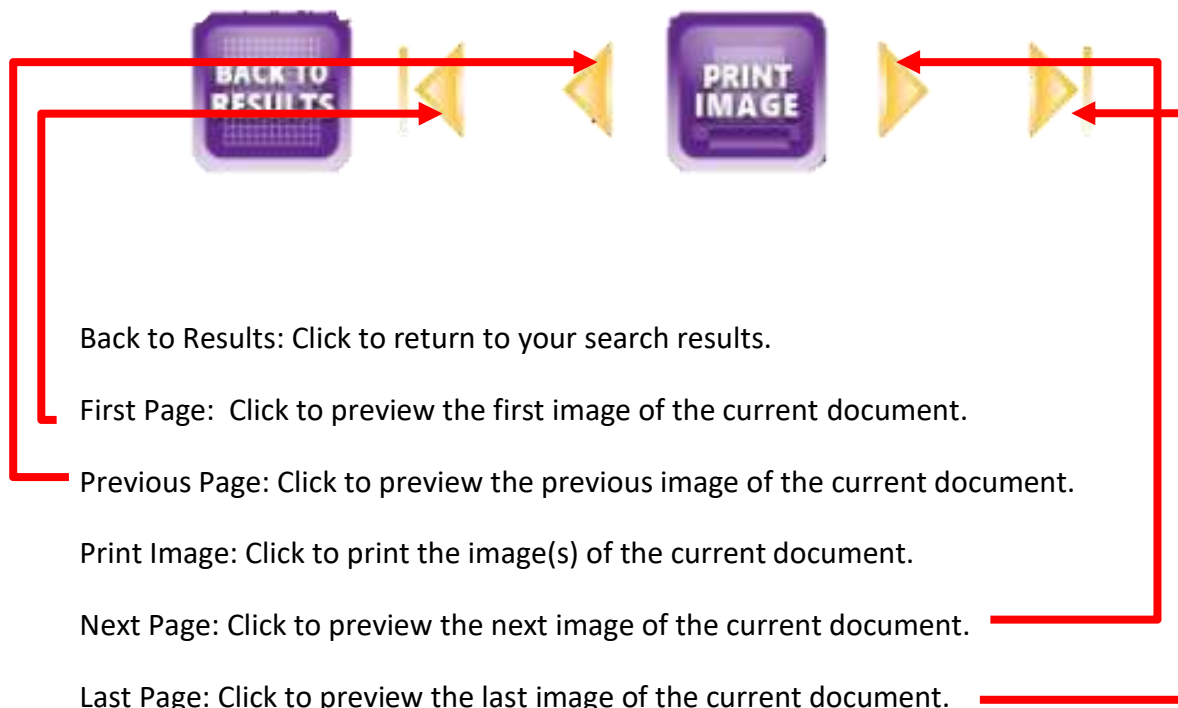
Purchase Certified Copy: (Optional) Where offered, this will take the user to the Official Records Online site for the county.

On the preview page, accessed when a user clicks the “View Image” button, you can preview each of the images before purchasing them by using the arrow buttons at the bottom of the page. Once you are ready to purchase the image(s), click on the “Print Image” button.

NOTE: The “Print Image” button does not charge you for the image(s) yet, this is done on the next page.



Preview Image Buttons:



Go To Page: When previewing images, enter the page number (i.e. 1,3,6,10) and click “Go To Page” to skip directly to the image to preview.



Receipt: At any time using Tapestry, you can click the “Receipt” button to view and print an itemized total of your charges.

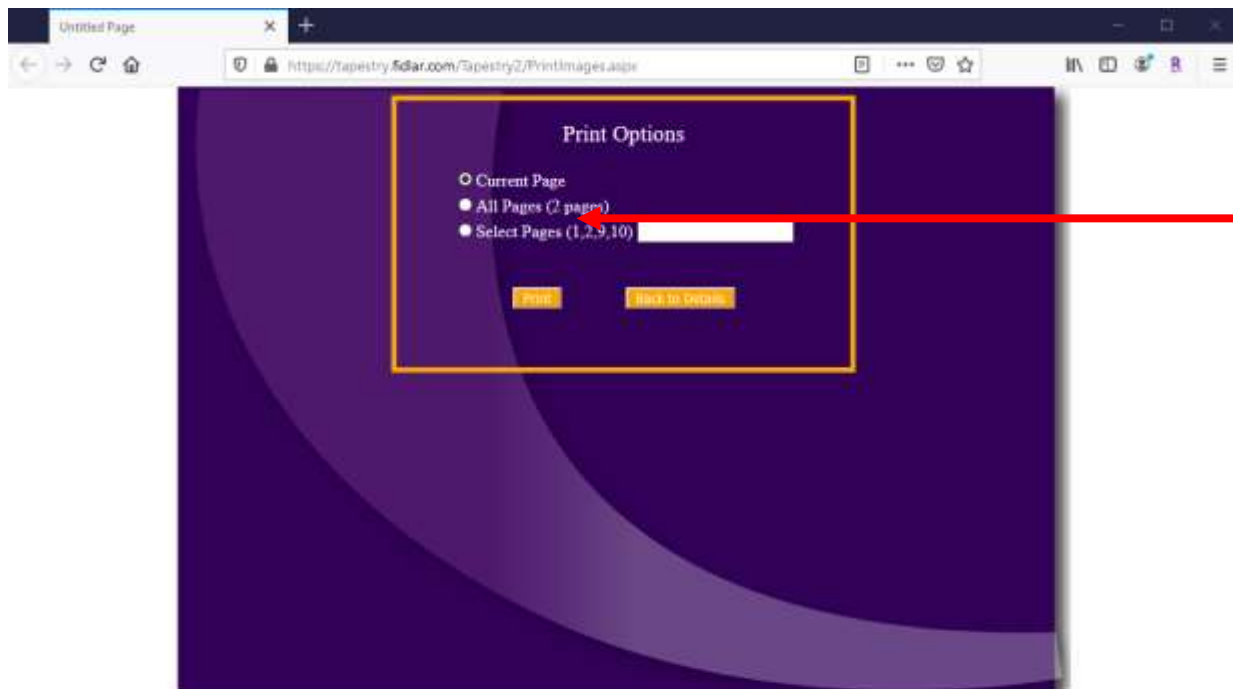


On the “Print Options” page, accessed when a user clicks “Print Image”, you can click to either:

- Current Page: the last image that was on your screen
- All Pages (# pages): all pages in the selected document
- Select Pages (1,2,9,10): only user-identified pages from the current document

Once you are ready to print, click the “Print” button.

NOTE: Clicking the “Print” button charges you for the image(s). All images from Tapestry are generated as PDFs. Please make sure you have Adobe Acrobat installed before clicking the “Print” button.



On the printed images page, you have the option to either print the image(s) directly from your web browser or save the PDF to your computer to print later.
